RESOLUTION NUMBER R- 303904

DATE OF FINAL PASSAGE JUL 15 2008

WHEREAS, the National Insurance Crime Bureau [NICB] is the nation's leading not-for-profit organization dedicated exclusively to preventing, detecting, and defeating insurance fraud and vehicle theft through information analysis, investigations, training, and public awareness; and

WHEREAS, the NICB wishes to provide a grant to the San Diego Police Department for the purpose of investigating vehicle thefts, recovering stolen vehicles, and related activities;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee, including the Chief of Police, be and is hereby authorized and empowered, for and on behalf of the City of San Diego, to enter into an agreement with and to accept funds from NICB for the purposes set forth in the agreement, on file with the City Clerk's Office as Document No. RR- 303904.

BE IT FURTHER RESOLVED, that this authority includes the execution of all aspects of fund and program operation, including any amendments, extensions, augmentations, or renewals of funding from the NICB, for a period of up to five years, so long as there are no material changes to the scope and effort of the grant activities.


BE IT FURTHER RESOLVED, that the Auditor and Comptroller is authorized to accept, appropriate and expend an amount not to exceed \$15,000 per year for up to five years in grant funds if grant funding is secured.

BE IT FURTHER RESOLVED, that the City shall comply with all applicable statutory and regulatory requirements.

BE IT FURTHER RESOLVED, that any resources received hereunder shall be used to supplement and not to supplant expenditures controlled by this body.

BE IT FURTHER RESOLVED, that this agreement is subject to the City's Equal Opportunity Contracting (San Diego Ordinance No. 18173, San Diego Municipal Code Sections 22.2701 through 22.2702) and Non-Discrimination in Contracting Ordinance (San Diego Municipal Code Sections 22.3501 through 22.3517).
