DATE OF FINAL PASSAGE JUL 15 2008

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DECLARING A CONTINUED STATE OF EMERGENCY REGARDING THE WILDFIRES.

WHEREAS, California Government Code section 8630 authorizes local governing bodies to proclaim local emergencies when such events occur as are defined by California Government Code section 8558(c), provided further by Section 8630 that the local governing body must review the state of emergency at its regularly scheduled meetings or every twenty-one days until such emergency is declared to be terminated; and

WHEREAS, on October 29, 2007, the City Council adopted Resolution No. R-303098 declaring the existence of a local emergency regarding the wildfires which began on October 21, 2007, in the areas of the City of San Diego; and

WHEREAS, the City Council finds that a local emergency continues to exist in the City of San Diego due to the above-described wildfires; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to California Government Code section 8630, a continued state of emergency is declared to exist in the City of San Diego due to the wildfires which began on October 21, 2007.

BE IT FURTHER RESOLVED, that the measures previously taken by the City Council
in Resolution No. R-303098 shall continue to have full force and effect.
