WHEREAS, Calvin "Ollie" Baugh is the epitome of the American success story; having grown up in Mississippi during the 1960's amid racial turmoil, he proudly served his country in the United States Army and overcame many hardships to become the man of leadership that he was until his untimely death on April 18, 2008; and

WHEREAS, Calvin began his career at the City of San Diego on July 9, 1991 as an Assistant Laboratory Technician in the Water Utilities Department and was promoted in 1994 to Laboratory Technician in the Metropolitan Waste Water Department [MWW] Environmental Monitoring and Technical Services Division [EMTS], where he worked until his recent passing; and

WHEREAS, Calvin was instrumental in the creation of the highly successful Diversity Committee in the EMTS Division and worked tirelessly to assist other MWW divisions to form their own programs, for which he was awarded the City's Diversity Distinction Award in 2000; and

WHEREAS, Calvin was a highly successful musician using the stage name "Calvin Romance" and performed with the likes of Jonathan Butler, The Temptations, Pete Escavedo and David Foster; and

WHEREAS, Calvin founded the popular San Diego band "Quiet Storm," which performed regularly at Humphrey's Concerts by the Bay in the Backstage Lounge; and


WHEREAS, Calvin enjoyed performing at City employee events, never missing an opportunity to share his talents with his union and often told people that "Quiet Storm" was the official MEA band; and

WHEREAS, in 1994 Calvin and his good friend Nelda Gatlin created the Cal's Kids Foundation, a non-profit organization dedicated to the education of children, the mission being to motivate children to succeed to their fullest potential; and

WHEREAS, Calvin considered his greatest achievement in life to be his three children, sons "Little Cal" and Stefan and daughter Celene; NOW, THEREFORE,
