BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City Council allocates and the City Auditor/Comptroller is authorized to expend \$30,000 from Council District 7 Infrastructure Fund 10529 to the San Diego Chapter of the American Red Cross for the purchase of a Disaster Services Vehicle, contingent upon the Auditor/Comptroller certifying that funds are available.
