A RESOLUTION APPROVING ALLOCATION OF COUNCIL DISTRICT 7 INFRASTRUCTURE FUNDS TO THE RETIRED SENIOR VOLUNTEER PATROL [RSVP] FOUNDATION

WHEREAS, the volunteers of the Retired Senior Volunteer Patrol [RSVP] Foundation assist area stations in providing an increased level of crime prevention programs within specific geographic boundaries by providing additional resources to the San Diego Police Department; and

WHEREAS, the RSVP is in need of additional resources;


WHEREAS, the City Council has determined that there is a public purpose in providing City funds to the RSVP for the purchase of purchasing digital cameras and traffic cones, much needed resources necessary to the continuation of RSVP programs throughout District 7 and the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City Council allocates and the City Auditor/Comptroller is authorized to expend \$3,500 from Council District 7 Infrastructure Fund 10529 to RSVP for the purchase of digital cameras and traffic cones, contingent upon the Auditor/Comptroller certifying that funds are available.

2. That the Mayor or his designee is authorized to enter into a donation agreement with the RSVP, a copy of which is on file with the Clerk's office as document no. RR **303949**
