DATE OF FINAL PASSAGE JUL 2 2 2008

DRAINAGE EASEMENT VACATION IN LOT 346 OF MAP 5011.

WHEREAS, California Streets and Highways Code section 8330 et seq. (and specifically Sections 8333 and 8335), and San Diego Municipal Code section 125.1010(c) provide a procedure for the summary abandonment or vacation of public service easements by City Council resolution where the easement to be vacated has been superseded by relocation and there are no other public facilities located within the easement; and

WHEREAS, the affected property owner has requested the vacation of a section of the public service [drainage] easement in Lot 346 of San Carlos Estates Unit No. 3 Map No. 5011 as depicted on Engineering Drawing No. 20795-B, to unencumber his/her property. Said drainage easement is located in the Navajo Community Plan area, on the west side of Norman Lane south of Madra Avenue; and

WHEREAS, this drainage easement was originally granted to the City at no cost in or around 2003; and

WHEREAS, the existing public utility facilities located within the section of the drainage easement to be abandoned have been superseded with a new drain as shown on Engineering Drawing No. 20574-B, in order to accommodate a construction change to the grading plan approved September 30, 2005 on Engineering Drawing No. 33364-D (W.O. 423556); and

WHEREAS, there are no other public facilities located within that section of the drainage easement to be abandoned, and there is no present or prospective public use of the existing drainage easement in its present location; and

WHEREAS, this action is exempt from the California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); and

WHEREAS, under Charter section 280(a)(2) this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body, a public hearing was required by law implicating due process rights of individuals affected by the decision, and the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; and

WHEREAS, the matter was set for public hearing on JUL 2 2 2008, testimony having been heard, evidence having been submitted, and the City Council having fully considered the matter and being fully advised concerning the same; NOW, THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego [City Council] finds that:

- (a) the drainage easement to be abandoned herein does not contain public utility facilities or does not contain active public utility facilities that would be affected by the abandonment; and
- (b) the drainage easement has been superseded by relocation and there are no other public facilities located within the easement;
- (c) there is no present or prospective use for the drainage easement, either for the facility or purpose for which it was originally acquired, or for any other public use of a like nature that can be anticipated;

- (d) the public will benefit from the vacation through improved utilization of land made available by the abandonment;
- (e) the abandonment is consistent with any applicable land use plan, including the C1ty's General Plan and the Mira Mesa Community Plan; and
- (f) the public facility or purpose for which the drainage easement was originally acquired will not be detrimentally affected by the abandonment or the purpose for which the drainage easement was required no longer exists.

BE IT FURTHER RESOLVED, that the City Council finds as follows:

- 1. That the portion of the drainage easement located within Lot 346 of San Carlos Estates Unit No. 3 Map No. 5011, as more particularly described in the legal description marked as Exhibit "A," and shown on Drawing No. 20795-B, marked as Exhibit "B," and on file in the office of the City Clerk as Document Nos. RR- 303952, and RR- 303952, which are by this reference incorporated herein and made a part hereof, is ordered summarily abandoned.
- 2. That the City Clerk shall cause a certified copy of this Resolution, with attached exhibits, attested by her under seal, to be recorded in the office of the County Recorder. From and after the date of recordation of this Resolution, the abandoned drainage easement shall no longer constitute a public service easement. Upon such recordation, the abandonment is complete.

BE IT FURTHER RESOLVED, the City Council finds that this action is exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities).

THENCE CONTINUING ALONG SAID NORTHEASTERLY LINE SOUTH 59°27'00" EAST, 35.30 FEET TO THE BEGINNING OF A TANGENT 122.00 FOOT RADIUS CURVE CONCAVE SOUTHWESTERLY;

THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 14°59'32", A DISTANCE OF 31.92 FEET;

THENCE LEAVING SAID NORTHEASTERLY LINE SOUTH 39°26'10" WEST, 49.91 FEET TO A POINT ALONG SAID DRAINAGE EASEMENT AS DEDICATED ON MAP NO. 5011, BEING A POINT ON A NON-TANGENT 27.50 FOOT RADIUS CURVE CONCAVE SOUTHWESTERLY, A RADIAL LINE TO SAID POINT BEARS NORTH 83°51'21" EAST;


