A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING THE TRANSFER OF FUNDS FROM THE REDEVELOPMENT AGENCY IN THE AMOUNT NOT TO EXCEED \$1,600,000; AUTHORIZING THE APPROPRIATION AND EXPENDITURE OF THE FUNDS FOR THE MIDWAY PACIFIC HIGHWAY CORRIDOR AND OLD SAN DIEGO COMMUNITY PLAN UPDATES.

WHEREAS, the Council of the City of San Diego [City] implements projects to improve economic and physical conditions in the City of San Diego; and

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] and the City desire to cooperate in the implementation of the proposed Midway-Pacific Highway Corridor, and Old San Diego Community Plan update process; and

WHEREAS, the City wishes to accept tax increment funds from the Agency in an amount not to exceed \$1,600,000 for the purpose of executing a consultant agreement which will provide professional services to assist in the development of new community plans for the communities of Midway-Pacific Highway Corridor and Old San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Council does hereby authorize the City's acceptance, appropriation and expenditure of the funds from the Agency in an amount not to exceed \$1,600,000 for implementation of the community plan updates.

2. That the Council authorizes the Auditor and Comptroller, following completion of the Plan Updates, and upon the advice of the administering department, to transfer excess funds, 1f any, to Fund 98070, North Bay Redevelopment Project Area.

BE IT FURTHER RESOLVED, that this activity is not a "project" and is therefore not subject to the California Environmental Quality Act [CEQA], pursuant to State CEQA Guidelines Section 15060(c)(3).
