A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING CONSTRUCTION OF MEDIANS ON SCRIPPS RANCH BOULEVARD-CARROLL CANYON ROAD TO AVIARY DRIVE IN THE SCRIPPS RANCH MIRAMAR PLANNING AREA.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the plans and specifications for the construction of medians on Scripps Ranch Boulevard-Carroll Canyon Road to Aviary Drive [Project] as advertised by Purchasing and Contracting, filed in the office of the City Clerk as Document No. W.O. 523570, are approved.
2. That, after advertising for bids in accordance with law, the Mayor is authorized to award the Project contract to the lowest responsible and reliable bidder in an amount not to exceed \$1,100,000.00, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
3. That the expenditure of an amount not to exceed \$1,500,000 from CIP 52-357.0, Scripps Ranch Boulevard-Carroll Canyon Road to Aviary Drive, Fund 79007, Scripps Miramar Ranch Facilities Benefit Assessment is authorized solely and exclusively for the purpose of providing funds for the Project and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds are, or will be, on deposit with the City Treasurer.

4. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that this project is exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities).


