BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to appropriate and expend \$86,013 from CIP 62-337.0, Safe Routes to School Program – Florence Griffith Joyner Elementary School, Fund 30300, TransNet, for the purpose of design and construction of the project, contingent upon a fully executed grant agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess funds, if any, to the appropriate reserves.
