A RESOLUTION AUTHORIZING THE TRANSFER OF FUNDS FOR THE BALBOA PARK ORNAMENTATION AND CULTURAL PROJECTS.

BE IT RESOLVED, by the Council of the City of San Diego as follows:

- 1. That the Fiscal Year 2009 Capital Improvements Program Budget in CIP No. 21-855.0, Job Order 218553, Balboa Park Museum of Art Façade, in Fund 39010, Organ Pavilion is amended by increasing the budget amount by \$42,277.58.
- 2. That the Fiscal Year 2009 Capital Improvements Program Budget in CIP No. 21-855.0, Job Order 218553, Balboa Park Museum of Art Façade, in Fund 63023, COP 1C-1996A Surety Policy is amended by increasing the budget amount by \$4,000.
- 3. Authorizing the transfer of funds in the amount of \$8,399.29 from CIP 21-871.0, Marston House Improvements, to CIP 21-855.0, Job Order 218553, Balboa Park Museum of Art Façade within Fund 102244, TOT Unappropriated Reserves Balboa Park CIP.
- 4. Authorizing the City Auditor and Comptroller to appropriate and expend an amount not to exceed \$54,676.87 from CIP 21-855.0, Job Order 218553, Balboa Park Ornamentation/Cultural Projects (Museum of Art), (\$42,277.58 from Fund 39010, Organ Pavilion, \$4,000 from Fund 63023, COP 1C-1996A Surety Policy, and \$8,399.29 from Fund 102244, TOT Unappropriated Reserves Balboa Park CIP), for construction of Museum of Man ornamentation repairs.
- 5. Authorizing the Third Amendment to Agreement with Heritage Architecture and Planning for professional services for expanded scope of work on CIP 21-855.0, Balboa Park

Ornamentation/Cultural Projects (Museum of Man/California Tower, Museum of Art, Casa del Prado) in the amount of \$14,362.00, increasing the total amount to \$695,985.00.

6. That this activity is not a project and is therefore not subject to California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines Section 15060(c)(3).
