Perkins filed suit against the City of San Diego [City] alleging the exclusion of Motorcycle Care

Pay from the calculation of retirement benefits for police officers assigned to the Motors Unit.

Plaintiffs brought suit in the San Diego County Superior Court of the State of California. The suit is styled *Joseph A Lopez, William D Kingsbury, and Curtis E Perkins v City of San Diego, et al*, Case No. GIC 869054; and

WHEREAS, in the Closed Session Meeting of June 17, 2008, in the matter of *Steven A Sloan, Paul Hubka and Peter Mills v City of San Diego, et al*, (Case No. GIC 848641), and *Joseph A Lopez, William D Kingsbury, and Curtis E Perkins v. City of San Diego, et al*, (Case No. GIC 869054) the City Council voted 6 to 0 to approve the settlement. The motion was made by Council President Pro Tem Madaffer and the second by Councilmember Huesco. The motion passed 6 to 0 with Council President Peters and Councilmember Young absent

in the amount of \$223,100 00 made payable to Law Office of Michael A Conger.
