A RESOLUTION OF THE CITY OF SAN DIEGO
AUTHORIZING ACTIONS RELATED TO SUPPLEMENTAL
GRANT FUNDING FROM THE DEPARTMENT OF PUBLIC
HEALTH FOR LEAD HAZARD ENFORCEMENT PROGRAMS.

WHEREAS, in 2002, the City instituted the Lead Safe Neighborhoods Program to combat childhood lead poisoning, and

WHEREAS, the California Department of Public Health has grant funding available for such programs under its Lead Enforcement Supplemental Funding Program, and

WHEREAS, the City is eligible for this grant funding upon authorization by the Council,
NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1 That the Mayor or his designee is authorized to apply for, negotiate, and accept grant funding of \$537,543 from the California Department of Public Health in connection with the Lead Enforcement Supplemental Funding for Fiscal Year 2008-2009, to perform lead hazard enforcement and assist other local enforcement programs in the County of San Diego to develop lead hazard enforcement programs, and to execute grant agreement No 08-85089, on file in the office of the City Clerk as Document No RR- 304119.

2 That upon execution of the grant agreement, the City Controller is authorized to accept, appropriate, and expend \$537,543 in grant award funds from the California Department of Public Health under its Lead Enforcement Supplemental Funding for Fiscal Year 2008-2009

3. That the acceptance of grant funds is not a project and therefore is not subject to the California Environmental Quality Act [CEQA] pursuant to CEQA Guidelines sections 15060(c)(3) and 15378(b)(4), the proposed enforcement actions are categorically exempt from CEQA pursuant to CEQA Guidelines section 15321, and the proposed implementation of various health-related modifications to existing structures is categorically exempt from CEQA pursuant to CEQA Guidelines section 15301


