DATE OF FINAL PASSAGE SEP 23 2008

WHEREAS, the Wetlands Advisory Board [Board] is established in the San Diego Municipal Code to advise the Mayor, City Council and City Manager on public policy matters relating to conservation of wetlands in the City of San Diego; and

WHEREAS, the Board consists of nine members who serve three-year staggered terms, and each member shall serve until a successor is duly appointed and confirmed; and

WHEREAS, Board members shall consist of at least one wetland scientist; at least one land use expert; at least one representative with expertise in vernal pools, coastal salt marsh, riparian fresh water habitat and marine resources, with consideration given to geographic diversity; at least one representative from environmental organizations; and at least one member representing landowners; and


WHEREAS, members are appointed by the Mayor and confirmed by the City Council; and

WHEREAS, three members are now eligible for reappointment; NOW, THEREFORE,
