DATE OF FINAL PASSAGE SEP 23 2008

WHEREAS, the Old Town Planned District Design Review Board [Board] is established in the San Diego Municipal Code to advise the Planning Director on architectural design for development projects in compliance with the Planned District regulations and procedures; recommend to the Planning Commission any necessary changes to development regulations; recommend that the Planning Director approve, modify or disapprove any application for a permit based upon compliance or noncompliance with the adopted regulations and approved standards and criteria; and

WHEREAS, the Board consists of seven members who serve four-year staggered terms; and

WHEREAS, all members of the Board are to be residents of the County of San Diego and, are to be specifically qualified by reason of training or experience in history, art, architecture, land development, landscape architecture, tourism, planning or other relevant business or profession to judge the aesthetic effects of a proposed development; and


WHEREAS, three members are to be property owners in the Old Town San Diego Community Planning area; at least one member shall be a registered architect in the state of California; two members shall be members of the Old Town Community Planning Committee; one member shall be a business licensee; and one member shall be a resident within the Old Town San Diego Community Planning District; and

WHEREAS, one member is now eligible for reappointment; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following reappointment by the Mayor of the City of San Diego, to serve as a member of the Old Town Planned District Design Review Board, for a term ending as indicated, be and the same is hereby confirmed:


