



RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A COOPERATIVE AGREEMENT WITH CALTRANS FOR THE LAUREL STREET (CABRILLO) BRIDGE OVER STATE ROUTE 163 IN THE BALBOA PARK COMMUNITY PLAN AREA.

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with CALTRANS, for the purpose of preparing the project report, environmental document, plans, specifications and estimate for the seismic retrofit and rehabilitation of the Laurel Street (Cabrillo) Bridge over State Route 163, CIP 53-061.0 under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR 304147 together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the Mayor shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement

BE IT FURTHER RESOLVED, that this activity is not subject to CEQA pursuant to State CEQA Guidelines Section 15060(c)(3) CALTRANS will be the CEQA Lead Agency for any construction work as described in the Cooperative Agreement and will involve the City as a Responsible Agency


