WHEREAS, Joseph Powell is the Business Manager/Financial Secretary-Treasurer of the Sheet Metal Workers' Local 206, representing approximately 1,200 members, where he serves as Chairman of the committee which negotiates wages, hours and conditions of employment; and

WHEREAS, Joseph Powell serves as trustee on all negotiated trust funds and is responsible for employer-to-union relations, where he manages current contracts and maintains local union policies; and

WHEREAS, Joseph Powell serves in numerous capacities with Local 206 affiliates; he is Chairman of the San Diego Joint Apprenticeship Training Committee, Executive Board Member for the AFL-CIO Central Labor Council, Co-Chairman for the Local 206 401(a) plan and Executive Board Member of the San Diego Building and Construction Trades Council; and

WHEREAS, in 1988, Joseph Powell began his career with the Sheet Metal Works' Local 206 with his entrance into the four-year apprenticeship program, where he worked for University Mechanical along with going to school in the evenings; and

WHEREAS, in 1992, Joseph Powell became a Journeyman and became a foreman with University Mechanical, where he managed manpower, time schedules, shop fabrication, materials and detailed shop drawings; and

WHEREAS, along with his responsibilities as foreman, in 1997, Joseph Powell became an instructor with the San Diego Joint Apprenticeship Training Center, which he still serves as today, and

WHEREAS, in 1994, Joseph Powell was elected as Conductor for Sheet Metal Workers' Local 206, where he served until 1997 when he was elected as Trustee of the Sheet Metal Workers' Local 206; and

WHEREAS, in 2000, Joseph Powell was elected as Business Representative of his Local and was responsible for the dispatching of members, handling grievances and oversight of the organizational department and compliance program, and


WHEREAS, since 2004, Joseph Powell has served as Business Manager and Financial Secretary-Treasurer of Local 206, and
