A RESOLUTION AUTHORIZING UTILITY AGREEMENT AWARD AND EXECUTION; EXPENDITURE OF FUNDS FOR AGREEMENT PURPOSES; AND TAKING RELATED ACTIONS

WHEREAS, Caltrans will be constructing freeway widening improvements to Interstate 15, requiring the relocation of the City of San Diego Water Department's Miramar Cross Pipeline; NOW, THEREFORE

BE IT RESOLVED, by the Council of the City of San Diego, as follows

- 1. That the Mayor or his designee is hereby authorized and empowered to execute, for and on behalf of the City, a Utility Agreement with Caltrans, which is on file in the office of the City Clerk as Document No. RR 304173 for the purpose of the relocation of the existing 36-inch Miramar Cross Pipeline into Maya Linda Road between Carroll Canyon and Gold Coast Roads; and
- That the expenditure of an amount not to exceed \$116,600 00, from Water Fund 41500, CIP No 73-024.0, AA Freeway Relocation, is hereby authorized, solely and exclusively for the purpose of providing funds for the abovementioned Utility Agreement and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds are, or will be, on deposit with the City Treasurer, and
- That the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves, and
- That this activity is statutorily exempt from the California Environmental Quality

 Act [CEQA] pursuant to State CEQA Guidelines Section 15282(k) (pipelines less than one mile)
