A RESOLUTION AUTHORIZING EXECUTION OF AN AGREEMENT FOR GRANT FUNDS, AUTHORIZING THE EXPENDITURE OF FUNDS, AND TAKING RELATED ACTIONS.

WHEREAS, On October 24, 2007, President George W Bush declared California a major fire disaster area, allowing federal funds to be made available to local governments of fire affected areas in Southern California; and

WHEREAS, In January 2006, the City of San Diego [City] acted under the authority of the Mayor to address fire related damage threatening the safety of citizens and property, and

WHEREAS, The City hired Geosyntec as a consultant to assess the fire affected areas and to recommend mitigation plans for the most critical sites; and

WHEREAS, The City of San Diego [City] plans to implement Geosyntec's recommended mitigation measures for the Dulzura Conduit to preclude potential problems from exacerbating the damage the fire has already caused;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego.

That the Mayor or his designee is authorized to apply for, accept and execute, for and on behalf of said City, an Agreement with the Natural Resources Conservation Service [NRCS] for Emergency Water Protection [EWP] grant funds for the Dulzura Conduit Concrete Covers Project under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR 304179

- 2 That the appropriation ordinance is amended to add CIP 75-941.0, Dulzura Conduit Concrete Covers, to the Fiscal Year 2009 Capital Improvements Program.
- 3. Authorizing the Mayor or his designee to transfer \$700,000 from Water DRES

 Reserve Account to CIP 75-941.0, Dulzura Conduit Concrete Covers, within Fund 41500 Water

 Department.
- 4. Authorizing the City Auditor and Comptroller to appropriate and expend an amount not to exceed \$700,000 from CIP 75-941.0, Dulzura Conduit Concrete Covers, Water Fund 41500, for the purpose of installing concrete covers along the Dulzura Conduit.
- 5 Authorizing the City Auditor and Comptroller, upon advice from the administering department, to transfer excess funds, if any, to the appropriate reserve.
- That this activity is exempt from the California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines Section 15269.
