WHEREAS, David Rodriguez was an important part of a team stewarding a number of technological upgrades to Urban Corps operations, helping bring the organization up to 21<sup>st</sup> Century standards, establishing an organization-wide networking system and incorporating “Efforts to Outcomes” [ETO] software used for tracking Urban Corps records and successes, and

WHEREAS, David Rodriguez has an extensive background in the political arena and in intergovernmental and human relations and has been a community leader for over 25 years, acting as Political Director for the Viejas Band of Kumeyaay Indians, CEO of the Native American Corporate America Business Conference and working with the National Conference of Christians and Jews [NCCJ], and

WHEREAS, David Rodriguez currently serves on the Board of Directors of the National Association of Service and Conservation Corps [NASCC] in Washington, D C , and

WHEREAS, the Urban Corps will truly miss David Rodriguez as he continues his life's journey in Washington, D C , where he will serve as Director of Communications and External Affairs for the National American Indian Housing Council, NOW, THEREFORE,
