A RESOLUTION APPROVING AND FUNDING THE
SETTLEMENT OF PROPERTY DAMAGE CLAIM BY
MERLE RICHMAN AND SUSAN T. TRAN

WHEREAS, on March 27, 2007, a residential home owned by Merle Richman and Susan T. Tran, located at 8376 La Jolla Shores Drive, was damaged by flooding, which occurred as the result of a sewer backup.

WHEREAS, the City of San Diego, Merle Richman and Susan T. Tran, now desire to resolve and settle all claims; and

WHEREAS, the City in closed session on September 9, 2008, authorized settlement of all claims for an amount consistent with the amounts set forth below, NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor is authorized to pay the sum of \$96,042.42 in settlement of each and every claim against the City, its agents and employees, resulting from the Property Damage Claim of Merle Richman and Susan T. Tran.

BE IT RESOLVED, by the Council of the City of San Diego, that the City Auditor and Comptroller is authorized to issue one check in the amount of \$96,042.42, made payable to Merle Richman and Susan T. Tran.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the expenditure of an amount not to exceed \$96,042.42 from Metropolitan Wastewater Department

Fund 41506, Sewer Revenue Fund, is hereby authorized solely and exclusively for the purpose of providing funds for the full settlement of the above-mentioned lawsuit and of all claims.
