DATE OF FINAL PASSAGE OCT 27 2008

WHEREAS, Certified Public Accountants [CPA] Tom Abbas and Rulon Jenson formed Abbas, Jenson & Cundari on September 20, 1987; a third partner, Chris Cundari, CPA joined the accounting firm in January 1993; and

WHEREAS, as Abbas, Jenson & Cundari expanded, the office was moved into Hillcrest, where it continued to grow over the next ten years; in the fall of 2003, the practice was moved into the firm's current Bankers Hill location on Fifth Avenue; and

WHEREAS, Abbas, Jenson & Cundari offers a variety of tax and accounting services tailored to meet the needs of both small businesses and individuals, including individual, corporation, partnership, limited liability company and nonprofit association tax returns, payroll processing, financial statement preparation and consulting for small businesses; and

WHEREAS, with a professional staff of four and three support staff, Abbas, Jenson & Cundari serve over 2,000 businesses and individuals in San Diego County and throughout the United States; and

WHEREAS, Tom Abbas is a native San Diegan who grew up in Santee and graduated in 1983 from San Diego State University with a Bachelor of Science degree in Accounting and began his career as a staff accountant with West, Johnston, Turnquist and Schmitt; Tom received his Certified Public Accountant's license in California in 1986; and

WHEREAS, Tom Abbas has served on the board of directors for several nonprofit organizations in San Diego, including America's Finest City Softball League, GSDBA Charitable Foundation, San Diego Industrial Recreation Council and Special Delivery San Diego; and

WHEREAS, Rulon Jenson is a 1980 graduate of San Diego State University and was licensed as a CPA in Florida and California; after five years with the national accounting firm of McGladrey & Pullen, he established his own accounting practice; and


WHEREAS, Rulon Jenson is active in the community and has served on the board of directors for several local nonprofit organizations; and


