WHEREAS, after the Cedar Fire, Gloria joined the Project Phoenix Organizing Committee, where she spent months at the Scripps Ranch Local Assistance Center as a Community Liaison, organized a meeting with Insurance Commissioner John Garamendi and various insurance company representatives and Co-Chaired the SRCA's Community Unity Event, which brought together members of the Scripps Ranch Community one year after the fire; and

WHEREAS, Gloria has served as the Ellen Browning Scripps Elementary School Academic Fundraising President, the Chair of the Ellen Browning Scripps Elementary School's Design Task Force and as a member of the Site Governance Team/School Site Council, and has been the driving force for many improvements and enhancements, including the installation of a security gate in 2004 and the addition of the Pre-K Primary Education Program; and


