A RESOLUTION AUTHORIZING THE EXPENDITURE FOR AT-GRADE CROSSING AND TRAFFIC SYNCHRONIZATION IMPROVEMENT PROJECT.

BE IT RESOLVED, by the Council of the City of San Diego as follows:

- 1. That the City Comptroller is authorized to expend an amount not to exceed \$100,000 from CIP No. 59-021.0, Fund No. 30310, TransNet for the purpose of contributing local funds as a match for the At-Grade Crossing and Traffic Synchronization Improvement Project, contingent upon receipt of a fully executed grant agreement with SANDAG.
- 2. That this activity is not a "project" and is therefore exempt from California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines section 15060(c)(2). Any construction activities related to this approval will be subject to environmental review.
