BE IT FURTHER RESOLVED, that an increase of \$406,512 in the Fiscal Year 2009 Capital Improvements Program Budget in CIP No. 29-981.0, Carmel Mountain Ranch

Children's Play Area Improvements, is authorized contingent upon receipt of a fully executed grant agreement.

BE IT FURTHER RESOLVED, that the transfer of \$150,000 from CIP No. 37-064.0, Americans with Disability Act (ADA) Improvements Annual Allocation, Fund No. 302453 Capital Outlay to CIP No. 29-981.0 Carmel Mountain Ranch Community Park Children's Play Area Improvements, Fund No. 302453 Capital Outlay is authorized, contingent upon receipt of a fully executed grant agreement.

BE IT FURTHER RESOLVED, that the City Comptroller is authorized to appropriate and expend \$406,512 from CIP No. 29-981.0, Carmel Mountain Ranch Community Park Children's Play Area Improvements, contingent upon receipt of a fully executed grant agreement.

BE IT FURTHER RESOLVED, that this project is exempt from California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines Section 15301.
