

RESOLUTION NUMBER R- 304480  
DATE OF FINAL PASSAGE DEC 15 2008

WHEREAS, During the first few hours and days after a disaster strikes, emergency services could be overwhelmed, leaving families, neighborhoods and businesses on their own for hours or days; and,

WHEREAS, After the devastating Cedar fire of October 2003, the City of San Diego sought new solutions to prevent emergency services from being overwhelmed; and,

WHEREAS, A new community based program called Community Emergency Response Team (CERT) was developed by the Fire-Rescue department. CERT San Diego helped citizens become a part of the solution in their own communities; and,

WHEREAS, San Diego Fire-Rescue personnel train and empower citizens in safe, effective neighborhood CERT teams. CERT San Diego instructors teach citizens to take life-saving action to help families, neighbors, businesses and communities get through the first few hours or days when emergency services are overwhelmed; and,

WHEREAS, the Tierrasanta community has established a local CERT program (T-CERT) in accordance with the CERT San Diego guidelines; and,

WHEREAS, the City desires to purchase certain emergency equipment to be utilized by T-CERT for training and when activated during an emergency; and,

WHEREAS, Developer Agreement Funds in the amount of at least \$95.78 are remaining in fund 392018 "Lusk—RoadRunner Park" from the Development Agreement (D.A.) between the City and County of San Diego and Tierrasanta L-L Partnership (Lusk) entered into pursuant to City Council Policy 600-67, adopted by the City Council on August 9, 1988 and amended on September 13, 1988. These funds were established per Council Ordinance 00-15153, to be used for reimbursable costs to landscape Roadrunner Park; and,

WHEREAS, Developer Agreement Funds in the amount of at least \$36,122.21 are remaining in fund 392021 "R.H.—Recycling Center" and in the amount of at least \$13,782.01 "R.H. – Community Entrance Signs" from the D.A. between the City of San Diego and Regency Hills Associates (case No. 88-0907) entered into pursuant to City Council Policy 600-67, adopted by the City Council on August 9, 1988 and amended on September 13, 1988; and,

WHEREAS, the intent of each fund identified above has been satisfied and the City Council may authorize the expenditure of these funds for any General Fund purpose.

NOW THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that the entire fund balance from Fund No. 392018 – "Lusk – Roadrunner Park" be transferred to Fund No., 10407 – "Tierrasanta CERT".

BE IT FURTHER RESOLVED, that the entire fund balance from Fund No. 392021 – "R.H. – Recycling Center" be transferred to Fund No., 10407 – "Tierrasanta CERT".

BE IT FURTHER RESOLVED, that up to \$13,782.01 be transferred from Fund No. 392018 – "R.H. Community Entrance Signs" to Fund No. 10407 – "Tierrasanta CERT" such that Fund No. 10407– "Tierrasanta CERT" will have a total balance of \$50,000.

BE IT FURTHER RESOLVED, that the Comptroller may appropriate and expend \$50,000 from Fund No. 10407- "Tierrasanta CERT" for the Fire-Rescue Department to purchase tools and equipment for use by T-CERT for training and when activated during an emergency and that any unexpended balances from Fund No. 10407 - "Tierrasanta CERT remain in that account for future T-CERT equipment, supplies and cache maintenance/replacement use as directed by the Fire-Rescue Department.
