RESOLUTION NUMBER R- 304550

DATE OF FINAL PASSAGE DEC 16 2008

WHEREAS, on November 29, 2004, the City Council adopted an ordinance, which is on file with the Office of the City Clerk as Document No. O-19337 and codified at San Diego Municipal Code sections 26.1801, 26.1802, and 26.1803, creating the Parking Advisory Board; and

WHEREAS, the Parking Advisory Board is to serve as an advisory body to the Mayor and City Council on policy issues relating to parking; and

WHEREAS, the ordinance originally required fourteen members to be appointed by the Mayor and confirmed by the City Council; and

WHEREAS, the ordinance requires the Mayor to appoint one at-large member; eight members, one each from a list of two nominations submitted by each Councilmember to represent his or her district; one member from each Community Parking District; one member from the Community Planning Committee; and one member from the Business Improvement District Council; and

WHEREAS, on June 27, 2005, the City Council adopted Resolution Nos. R-300584, R-300585, and R-300586, in which the City Council authorized the formation of three new Community Parking Districts for the communities of La Jolla, Pacific Beach, and Old Town; and

WHEREAS, on July 10, 2007, the City Council amended Section 26.1802 of the San Diego Municipal Code to increase the total membership of the Parking Advisory Board from fourteen members to seventeen members; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following reappointments by the Mayor of the City of San Diego to serve as members of the Parking Advisory Board be and the same are hereby confirmed:
