A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
SAN DIEGO SELECTING THE COUNCIL PRESIDENT PRO  
TEM AND CONFIRMING APPOINTMENTS TO THE  
STANDING COMMITTEES FOR CALENDAR YEAR 2009.

WHEREAS, on December 9, 2008, the City Council adopted Resolution No. R-304537, selecting Councilmember Ben Hueso as Council President to serve for a term of one year and until a successor is selected and qualified; and

WHEREAS, Rule 4.3 of the Permanent Rules of the City Council, San Diego Municipal Code section 22.0101.5, provides that the Council President shall, no later than the second meeting of the Council in January of each year, select a Council President Pro Tem, subject to confirmation by a majority of the City Council, to serve for a term of one year and until a successor is selected and qualified; and

WHEREAS, the Council President has selected Councilmember Kevin Faulconer to serve as Council President Pro Tem for a term of one year commencing January 1, 2009; and

WHEREAS, Rule 6.1 of the Permanent Rules of the City Council, San Diego Municipal Code section 22.0101.5, provides that there shall be five standing committees of the City Council; and

WHEREAS, Rule 6.2.1 provides that for each committee, except for the Committee on Rules, Open Government, and Intergovernmental Relations, the Council President shall, no later than the second meeting of the Council in January of each year, nominate the committee Chair, vice-chair, and committee members, subject to confirmation by a majority vote of the City Council; and

WHEREAS, the Council President has submitted nominations for each committee Chair, vice-chair, and committee members; and

WHEREAS, under Charter section 280(a)(1) this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that the selection by the Council President of Councilmember Kevin Faulconer to serve as Council President Pro Tem for a term of one year commencing January 1, 2009, is hereby confirmed.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the following appointments by the Council President to serve as Chairs, vice-chairs, and committee members of the five standing Council committees for a term of one year commencing January 1, 2009, be and the same are hereby confirmed:
