AN ORDINANCE OF THE CITY OF SAN DIEGO AUTHORIZING AMENDMENTS TO THE NON-EXCLUSIVE SOLID WASTE COLLECTION FRANCHISE AGREEMENTS.

WHEREAS, it is in the City's best interests to amend the current franchise agreements for solid waste collection services provided by private haulers in the City; and

WHEREAS, City staff have met and negotiated the proposed amendments with the affected franchisees; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, second amendments to the Class I Non-Exclusive Franchise Agreements for Solid Waste Management Services with the Class I Franchisees listed in the attached Exhibit "A," under the terms and conditions set forth in the form Second Amendment to Class I Non-Exclusive Franchise Agreement for Solid Waste Management Services on file with the City Clerk as Document Number OO-_______19854, effective July 1, 2009.

Section 2. That the Mayor or his designee is authorized to execute, for and on behalf of the City, first amendments to the Class II Non-Exclusive Franchise Agreements for Solid Waste Management Services with the Class II Franchisees listed in the attached Exhibit "A," under the terms and conditions set forth in the form First Amendment to Class II Non-Exclusive Franchise Agreements for Solid Waste Management Services on file with the City Clerk as Document Number OO
19854, effective July 1, 2009.

Section 3. That this activity is not a project and therefore is not subject to the California Environmental Quality Act [CEQA] pursuant to CEQA guidelines 15060(c)(3) and 15378.

Section 4. That a full reading of this ordinance is dispensed with prior to passage, since a written copy was made available to the City Council and the public prior to the day of its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
