AN ORDINANCE AUTHORIZING THE EXECUTION OF A SECOND AMENDMENT TO THE AGREEMENT WITH SOMACH, SIMMONS & DUNN FOR THE PURPOSE OF EXTENDING A LEGAL SERVICES CONTRACT FOR AN

DATE OF FINAL PASSAGE

ADDITIONAL FIVE YEARS.

WHEREAS, on December 9, 2002, by Resolution R-297484, the Council of the City of San Diego [City] adopted the Long-Range Water Resources Plan [LRWRP] to evaluate water supply alternatives for meeting the City's current and future water needs; and

WHEREAS, on April 20, 2004, City and Somach, Simmons & Dunn [Firm] entered into an Agreement for specialized legal services [Agreement] required by the Water Department to assist City in implementing the water resources strategy as recommended by the LRWRP; and

WHEREAS, during the term of the Agreement, City determined that it required Firm's services for an additional time period and therefore extended the term of the Agreement until March 31, 2009, by executing a First Amendment; and

WHEREAS, during the term of the Agreement extended by the First Amendment, City determined that it will require Firm's services for an additional time period and therefore desires to extend the term of the Agreement by five (5) years; NOW, THEREFORE:

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is hereby authorized to execute a Second Amendment to the Agreement with Firm, on file in the Office of the City Clerk as Document No. 19866, for the purpose of extending the Agreement for five (5) years until March

31, 2014, and increasing the funding for the Agreement by an amount not to exceed \$200,000

from Water Department Fiscal Year 2009 Operating Budget, Water Fund 41500, Org. 8310.

Section 2. That the expenditure of an amount not to exceed \$200,000 from Water

Department Fiscal Year 2009 Operating Budget, Water Fund 41500, Org. 8310, is authorized

solely and exclusively for the purpose of providing funds for the Agreement, its amendments and

related costs, provided that the City Comptroller first furnishes one or more certificates certifying

that the funds are, or will be, on deposit with the City Treasurer.

Section 3. That the City Auditor and Comptroller is authorized, upon advice from the

administering department, to transfer excess funds, if necessary, to appropriate reserves.

Section 4. That this activity is not a project and is therefore exempt from the

California Environmental Quality Act [CEQA], pursuant to CEQA Guidelines Section

15030(c)(3).

Section 5. That a full reading of this Ordinance is dispensed with prior to its final

passage, a written or printed copy having been available to the City Council and the public a day

prior to its final passage.

Section 6. That this Ordinance shall take effect and be in force on the thirtieth (30<sup>th</sup>)

day from and after its final passage.
