BE IT RESOLVED, by the Council of the City of San Diego, that it has reviewed and accepts the Developer Impact Fees Fiscal Year 2008 Annual Report, with attachments, more specifically identified as Report to the City Council No. 69-002, a copy of which is on file in the Office of the City Clerk as Document No. 304590.

BE IT FURTHER RESOLVED, that the Council finds, with respect to funds reflected in the Developer Impact Fees Fiscal Year 2008 Annual Report, or attachments thereto, as having

been collected over five years before July 1, 2008, and as stated in Attachment 6 of the

Developer Impact Fees Fiscal Year 2008 Annual Report, that the documentation: (1) Identifies

the purpose to which the fee is to be put; (2) Demonstrates a reasonable relationship between the

fee and the purpose for which it is charges; and (3) Identifies sources and amounts of funding

anticipated to complete financing of incomplete improvements and the approximate dates on

which such funding is expected to be deposited into the appropriate fund.

BE IT FURTHER RESOLVED, that the Council incorporates and adopts the findings set

forth in Attachment 6 of the Developer Impact Fees Fiscal Year 2008 Annual Report, entitled

"FINDINGS FOR FUNDS COLLECTED OVER FIVE YEARS AGO DEVELOPMENT

IMPACT FEES FISCAL YEAR 2008 ANNUAL REPORT."
