WHEREAS, Ms. McCullough helped lead the four-year Zoning Code Update to amend over 1,000 pages of the City's Municipal Code, which won the League of California Cities 2001 Helen Putnam Award for excellence in city government; and

WHEREAS, Ms. McCullough, for many years, has led groups of planners on annual pilgrimages to state and national planning conferences, where she nurtured their professional growth and development while providing legendary anecdotal memories; and

WHEREAS, Ms. McCullough, for over 30 years, has mentored hundreds of future planners, including her future husband Jim, to go forth and do meaningful work to improve the quality of life in San Diego's neighborhoods and communities; and

WHEREAS, Ms. McCullough has been a champion for public participation and community-based planning groups; and

WHEREAS, Ms. McCullough's professional accomplishments have been recognized by her peers of the California Chapter of the American Planning Association, who presented her with the 2007 Distinguished Leadership Award; and

WHEREAS, the punctuality, professionalism, idealism, and dedication to the highest standards of planning, which Ms. McCullough generously expended in pursuing quality planning in and for the City of San Diego, is recognized, applauded, cheered, admired, commended, praised, and enormously appreciated by a grateful City Council and the citizens of the City of San Diego; and

WHEREAS, throughout her career Ms. McCullough has provided the highest quality support, advice, and recommendations to Mayors, Councilmembers, City Managers and Planning Directors too numerous to count; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does herewith afford Ms. McCullough absolute freedom with all privileges to pursue other endeavors and to engage herself in the pursuit of happiness and other sundry pleasures of life and does hereby proclaim January 27, 2009, to be "BETSY MCCULLOUGH DAY" in recognition of her tremendous contributions to the City of San Diego Planning Department for the last 34 years.
