A RESOLUTION OF THE CITY COUNCIL AUTHORIZING THE TRANSFER OF FUNDS IN CONNECTION WITH THE ANNUAL ALLOCATION FOR METROPOLITAN WASTEWATER DEPARTMENT TRUNK SEWERS.

WHEREAS, the Metropolitan Wastewater Department [MWWD] is subject to a consent decree goal to replace 45 miles of sewer per year to reduce the potential for sewer spills and protect the public's health and safety; and

WHEREAS, the MWWD uses Annual Allocations to fund the upgrade and replacement of sewer mains throughout the City in need of repair due to deterioration or insufficient capacity; and

WHEREAS, the transfer of \$2.9 million from the Annual Allocation-Sewer Main

Replacements to the Annual Allocation – MWWD Trunk Sewers will fund accelerated projects;

NOW THEREFORE,

BE IT RESOLVED, by the City of San Diego that the Comptroller is authorized to

transfer the amount of \$2,900,000 from Fund 41506, CIP 44-001.0, Annual Allocation – Sewer Main Replacements to Fund 41506, CIP 40-933.0 Annual Allocation – MWWD Trunk Sewers.

BE IT FURTHER RESOLVED, that this activity is not a project and therefore is not subject to the California Environmental Quality Act pursuant to CEQA Guidelines section 15060(c)(3) and 15004.
