A RESOLUTION OF THE CITY OF SAN DIEGO AUTHORIZING THE TRANSFER AND EXPENDITURE OF FUNDS FOR THE RANSOM STREET / DARWIN WAY STORM DRAIN PROJECT.

WHEREAS, the existing storm drain at Ransom Street and Darwin Way is in need of replacement; and

WHEREAS, Council approved funding for this replacement project via Proposition 1B funds in May 2008; and

WHEREAS, the transfer of the Proposition 1B funds to the project is necessary; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the City Comptroller is authorized to transfer \$730,000 within Fund No. 38941, Proposition 1B, from CIP 13-005.0, Emergency Drainage Projects, to CIP 11-302.0, Ransom and Darwin Storm Drain Replacement Project.
- 2. That the City Comptroller is further authorized to appropriate and expend an amount not to exceed \$730,000 from Fund No. 38941, Proposition 1B, CIP 11-302.0, Ransom and Darwin Storm Drain Replacement Project, solely and exclusively for design, construction, and related costs of this project.
- 3. That the City Comptroller is further authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.

4. That the above activity is exempt from the	California Environmental Quality Act
pursuant to CEQA Guidelines section 15282(k) because	se it is a pipeline less than one mile in
length.
