## A RESOLUTION AUTHORIZING THE TRANSFER OF FUNDS FOR THE LOGAN HEIGHTS BRANCH LIBRARY.

WHEREAS, the Logan Heights Branch Library [Project] will provide a \$25,000 sq. ft. library to serve the Logan Heights community; and

WHEREAS, the San Diego City Council [Council] has previously approved actions necessary for this Project; and

WHEREAS, the previous Council actions authorized expenditures for this Project in the amount of \$13,702,403 for design, construction and Project related expenses (Document Nos. R-295242, R-297961, R-299708, R-300992, R-303475, and O-19774); and

WHEREAS, the First 5 Commission of San Diego entered in an agreement with the City of San Diego [City] to give \$4,000,000 to the City for their libraries, allocating \$1,000,000 each to the Logan Heights Library, the College/Rolando Library, the Serra Mesa/Kearny Mesa Library and the Skyline Hills Library (Document No. R-299708); and

WHEREAS, the Serra Mesa/Kearny Mesa Library has been completed and was only able to use a portion of their First 5 funding, leaving \$389,694 unused; and

WHEREAS, those funds are eligible to be transferred to the Logan Heights Library; and

WHEREAS, the First 5 Commission of San Diego is aware of the proposed transfer of funds to the Logan Heights Library and have agreed to allow the funds to be transferred to and used by the Logan Heights Library pending Council approval.

NOW THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego as follows:

- 1. That an increase of \$889,694 (\$389,694 of First 5, Fund No. 38030, and \$500,000 of Library Improvement System, Fund No. 102216) in Fiscal Year 2009 Capital Improvements

  Program Budget in CIP No. 35-101.0, Logan Heights Branch Library is authorized.
- 2. That the City Comptroller is authorized to transfer appropriations of \$389,694 from CIP No. 35-089.0, Serra Mesa Branch Library, to CIP No. 35-101.0, Logan Heights Branch Library within Fund No. 38030, First 5 Grant Fund.
- 3. That the City Comptroller is authorized to appropriate \$500,000 from Fund No. 102216, Library System Improvements to CIP No. 35-101.0, Logan Heights Branch Library.
- 4. That the City Comptroller is authorized to appropriate and expend \$389,694 from CIP No. 35-101.0, Logan Heights Branch Library, Fund No. 38030, First 5 Grant Fund, and to expend \$500,000 from CIP No. 35-101.0, Logan Heights Branch Library, Fund No. 102216, Library System Improvement, solely and exclusively for the purpose of providing funds for the design, construction and Project related expenses, provided that the City Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditures are, or will be, on deposit with the City Treasurer.
- 5. That the City Comptroller, upon the advice from the administering department, is authorized to return excess budgeted funds, if any, to the appropriate reserves.
- 6. That this activity is not subject to the California Environmental Quality Act [CEQA] pursuant to CEQA Guidelines Section 15378(c). This activity is a subsequent discretionary approval covered under Finding of No Significant Impact/Negative Declaration

No. 42-0267 (Logan Heights Branch Library). The activity is adequately addressed in the environmental document and there are no changes in circumstances, additional information, or project changes to warrant additional environmental review.
