WHEREAS, the American Cancer Society estimates that over 108,070 new cases of colon cancer will be diagnosed in 2009 and 49,960 individuals are expected to die from colon and rectal cancer combined; and

WHEREAS, in the State of California an estimated 5,185 individuals will die from colon and rectal cancer combined, and 14,080 new cases will be diagnosed; and

WHEREAS, more than 90 percent of people diagnosed with colon cancer are age 50 and older, and one third of colorectal cancer deaths could be prevented if everyone age 50 and older received regular colon cancer screenings; and

WHEREAS, detected early, colon cancer has a 90 percent chance of a cure; and
WHEREAS, education can help inform the public of methods of prevention and symptoms
that lead to early detection; and

WHEREAS, the City of San Diego wishes to help inform the public about colon cancer prevention and screening; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby proclaim March 2009 to be "COLON CANCER AWARENESS MONTH" in the City of San Diego, and does hereby encourage all members of the public to learn more about how to protect themselves from this deadly disease.
