BE IT RESOLVED, that the City Comptroller be and is hereby authorized to issue a check in the amount of, but not exceeding, \$275,000 made payable to Christine Leiendecker and her attorney of record, Michael R. McCabe, in full and final settlement of all claims.

BE IT FURTHER RESOLVED, that the City Council is hereby authorized to pay the sum of \$275,000 from the Public Liability Fund 41500.
