A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE ESTABLISHMENT OF NEW RATES AND FEES AND ADJUSTMENTS TO EXISTING RATES AND FEES FOR INCLUSION IN THE RATEBOOK OF CITY FEES AND CHARGES MAINTAINED IN THE OFFICE OF THE CITY CLERK.

WHEREAS, it is the policy of the City of San Diego to establish fees to recover the costs of providing services in accordance with the City of San Diego Administrative Regulation 95.25 and Council Policy 100-05 "User Fee Policy"; and

WHEREAS, Administrative Regulation 95.25 encourages transferring specific fee schedules listed in the Municipal Code and Council Resolutions to the standardized Ratebook maintained by the City Clerk; and

WHEREAS, San Diego Municipal Code section 22.1502 provides that the Park and Recreation Director shall have the authority to establish fees for the use of Park and Recreation facilities and services, subject to the approval of the City Manager [Mayor]; and

WHEREAS the Park and Recreation fee schedule was last revised in Fiscal Year 2006; and

WHEREAS, the Park and Recreation Department conducted a full evaluation of the costs and revenues associated with providing City services, in accordance with the California Constitution as well as the California Government Code, which authorize local jurisdictions to impose fees, charges, and rates in order to recover costs associated with provided services and the use of facilities; and

WHEREAS, on April 1, 2009, the Park and Recreation Department presented a Proposed Fee Schedule to the Budget and Finance Committee; and

WHEREAS, on April 1, 2009, the Budget and Finance Committee approved the Proposed Fee Schedule and forwarded it on to the City Council; and

WHEREAS, on April 20, 2009, a public hearing was held by the Council of the City of San Diego at which oral and written presentations were made regarding the new and revised fees; and

WHEREAS, ten days prior to the public hearing held in connection with Manager's Report No. 09-029 regarding Park and Recreation Proposed Fee Schedule, a notice was made available to the public that included an explanation of the proposed new fees and revisions to existing fees to be considered at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Proposed Fee Schedule, attached hereto as Exhibit A, a copy of which shall be maintained on file in the Office of the City Clerk, as Document RR-304205, is hereby adopted for the purpose of recovering the costs of Park and Recreation services and use of facilities.
 - 2. That the Proposed Fee Schedule shall be effective beginning July 1, 2009.
- 3. That the Mayor is hereby directed to review the fees annually to ensure that all reasonable costs incurred in providing services are being recovered and to approve fee schedules whenever possible in accordance with the City of San Diego Administrative Regulation 95.25.

4.	That the City Clerk is hereby directe	d to amend the City Ratebook to include the
fees attached hereto in Exhibit A.
