A RESOLUTION APPROVING THE UPDATED CITY CLERK'S FEE SCHEDULE AND AMENDING THE CITY OF SAN DIEGO RATEBOOK.

WHEREAS, it is the policy of the City to establish fees to recover the costs of providing services in accordance with the City of San Diego Administrative Regulation 95.25 and Council Policy 100-05 "User Fee Policy;" and

WHEREAS, Administrative Regulation 95.25 encourages transferring specific fee schedules listed in the San Diego Municipal Code and Council Resolutions to the standardized Ratebook maintained by the City Clerk; and

WHEREAS, the Office of the City Clerk is proposing an increase in the fee to provide a copy of the San Diego City Charter at the front counter from \$3.00 to \$11.50, and by mail from \$5.20 to \$14.20, in order to recover the cost of providing this service; and

WHEREAS, to meet the City Clerk's goals of access and efficiency, the City Clerk is also proposing updating the City Clerk Fee Schedule to reflect that hardcopy formats of certain documents are being eliminated as those documents are available online at no cost to the user; and

WHEREAS, the City Clerk submitted the proposed fee increase and updated City Clerk Fee Schedule at a public hearing of the Committee on Budget and Finance on April 1, 2009; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the fees reflected in the updated City Clerk Fee Schedule attached hereto as Attachment A, is approved.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to amend the City Ratebook to include the fees attached hereto as Attachment A.

BE IT FURTHER RESOLVED, that the fees reflected in Attachment A, are to be effective on July 1, 2009.
