A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE REVISED NEWSRACK PERMIT FEES AND DIRECTING THE CITY CLERK TO AMEND THE CITY RATEBOOK

WHEREAS, the City's Neighborhood Code Compliance Division [NCCD] charges an annual permit fee for all newsracks in the City of San Diego; and

WHEREAS, NCCD conducted a full evaluation of the costs and revenues associated with providing City services, in accordance with the California Constitution and California Government Code, which authorize local jurisdictions to impose fees, charges, and rates in order to recover costs associated with provided services; and

WHEREAS, it is the policy of the City to establish fees to recover the costs of providing services, in accordance with City of San Diego Administrative Regulation No. 95.25 ("Processing New and Revised Fees and Charges for Current Services") and Council Policy No. 100-05 ("User Fee Policy"); and

WHEREAS, Administrative Regulation No. 95.25 encourages transferring specific fee schedules listed in the San Diego Municipal Code and Council Resolutions to the standardized Ratebook maintained by the City Clerk; and

WHEREAS, NCCD submitted full cost recovery fees related to newsracks to the Committee on Budget and Finance on April 1, 2009; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that a citywide newsrack permit fee (except for the Gaslamp Quarter Planned District) of \$15 per newsrack per year (a \$5 increase from the original permit fee of \$10) is hereby approved.

BE IT FURTHER RESOLVED, that a newsrack permit fee in the Gaslamp Quarter Planned District of \$15 per newsrack per year (a \$5 increase from the original permit fee of \$10) is hereby approved.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to amend the City Ratebook to include the aforementioned newsrack permit fees.

BE IT FURTHER RESOLVED, that the aforementioned newsrack permit fees are to be effective beginning on January 1, 2010.
