A RESOLUTION OF THE CITY COUNCIL AUTHORIZING THE AWARD AND EXECUTION OF A CONTRACT WITH FOCUS PSYCHOLOGICAL SERVICES TO PROVIDE PSYCHOLOGICAL SERVICES TO THE POLICE DEPARTMENT, AND THE APPROPRIATION AND EXPENDITURE OF GENERAL FUNDS FOR CONTRACT PERFORMANCE

WHEREAS, law enforcement officers are exposed to traumatic events and crisis situations in the performance of their duties; and

WHEREAS, most people who experience a traumatic event or crisis situation will suffer mild to moderate, short-term effects, while some will be severely affected; and

WHEREAS, people who receive no psychological intervention are more likely to experience negative, long-term effects; and

WHEREAS, the San Diego Police Department [Department] recognizes critical incident stress as a risk factor for its officers and employees, and their families; and

WHEREAS, the Department has developed a comprehensive Critical Incident

Intervention Program to help its officers and employees, and their families, cope with traumatic
events and crisis situations; and

WHEREAS, for the past 18 years, FOCUS Psychological Services has provided the Department with psychological services as part of the Critical Incident Intervention Program; and WHEREAS, FOCUS Psychological Services responds with the Department's Emergency

Negotiation Team to conduct suicide interventions and provide assistance at other negotiation scenes; and

WHEREAS, the City of San Diego advertised a Request for Bids, Bid. No. 9451-09-G, to furnish psychological services to the Department; and

WHEREAS, on August 7, 2008, FOCUS Psychological Services submitted the only bid to the City of San Diego; and

WHEREAS, FOCUS Psychological Services possesses the requisite licenses, expertise, and personnel to fulfill the Contract requirements, including education and training; trauma treatment and crisis intervention; confidential employee counseling and psychotherapy; family counseling; and management counseling and miscellaneous research; and

WHEREAS, FOCUS Psychological Services is ready, willing, and able to provide the needed psychological services to officers and employees of the Department, and their families; and

WHEREAS, the Department wishes to enter into a two-year Contract with FOCUS Psychological Services, effective retroactively to October 1, 2008, and effective through September 30, 2010, with three additional one-year options to renew the Contract for fiscal years 2010 through 2013; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee, be and is hereby authorized and empowered, for and on behalf of the City of San Diego, to award and execute a Contract with FOCUS Psychological Services for the period October 1, 2008 through September 30, 2010, with three additional one-year options to renew, under the terms and conditions set forth in the Contract on file in the office of the City Clerk as Document No. RR- $\frac{304823}{304823}$

BE IT FURTHER RESOLVED, that the appropriation and expenditure of an amount not to exceed \$271,000 in general funds is authorized for the first year of this Contract.

BE IT FURTHER RESOLVED, that the appropriation and expenditure of an amount not to exceed \$284,550 in general funds is authorized for each of the remaining four years, if the Contract continues for the second year and is thereafter renewed.

BE IT FURTHER RESOLVED, that this Contract is subject to the City of San Diego's Equal Opportunity Contracting (San Diego Ordinance No. 18173, San Diego Municipal Code sections 22.2701 through 22.2702) and Non-Discrimination in Contracting Ordinance (San Diego Municipal Code sections 22.3501 through 22.3517).
