A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A THIRD AMENDMENT TO AN AGREEMENT WITH LAGUNA MOUNTAIN ENVIRONMENTAL, INC. FOR AS-NEEDED ARCHAEOLOGICAL MONITORING.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor or his designee is hereby authorized and empowered to execute, for and on behalf of said City, a third amendment to an agreement with Laguna Mountain Environmental, Inc., for consultant services and increase the maximum contract amount from \$1,400,000 to \$2,100,000 under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR 304325 together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the Mayor or his designee shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.
- 2. That the City Auditor and Comptroller is hereby authorized solely and exclusively to appropriate and expend an amount not to exceed \$700,000 from CIP No. 370280, Job Order No. 373027, Review for Various Underground Project, Fund No. 30101, Underground Surcharge-CIP, for the purpose of executing the third amendment to the agreement, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditures are, or will be, on deposit with the City Treasurer.
- 3. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that this activity is not a "project" and is therefore not subject to CEQA pursuant to State CEQA Guidelines Sections 15060(c)(3).
