A RESOLUTION OF THE CITY OF SAN DIEGO EXTENDING
THE DOWNTOWN PARKING PILOT PROGRAM AND
RECOGNIZING THE DOWNTOWN PARKING
MANAGEMENT GROUP [DPMG] AS THE ADVISORY
GROUP TO THE CENTRE CITY DEVELOPMENT
CORPORATION

WHEREAS, the Downtown Parking Management Group [DPMG] was formed in 2004;
and

WHEREAS, in November 2004 the Downtown Parking Pilot Program [Pilot] was
established pursuant to Council Resolution R-299867 which, with two previous extensions, is set
to terminate on April 30, 2009; and

WHEREAS, since 2004, the DPMG and City staff have analyzed downtown parking
issues extensively; and

WHEREAS, the City Council desires the Pilot to continue through October 31, 2009,
without interruption to allow for continuing evaluation; and

WHEREAS, the City Council finds and the DPMG is the appropriate advisory group to
the Centre City Development Corporation, which is the City Council appointed Parking
Advisory Board for the Downtown Community Parking District; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the Downtown Parking Pilot Program [Pilot] established pursuant to Council
Resolution R-299867 be extended through October 31, 2009.

2. That the Downtown Parking Management Group [DPMG] is recognized as the advisory group to Centre City Development Corporation which is the City Council appointed Parking Advisory Board for the Downtown Community Parking District.

3. That DPMG shall continue to directly collaborate with City staff and make recommendations on parking meter rates, time limits, and locations of meters and use of new meter technology within the Pilot area, and may also make recommendations on other parking matters pursuant to Council Policy 100-18.

BE IT FURTHER RESOLVED, that this activity is not a project and is therefore exempt from CEQA pursuant to State Guidelines Section 15060(c)(3).
