WHEREAS, Robert McNeely is a graduate of the Pacific Coast Banking School at the University of Washington, Seattle, and the School of Bank Marketing at the University of Colorado, Boulder; and

WHEREAS, Robert McNeely joined Union Bank in 1968 and rose through the ranks of the company, establishing himself as a key player in developing the bank's community reinvestment strategy in the late 1980s; and

WHEREAS, Robert McNeely was named to his post in corporate social responsibility in 1988 and named a senior vice president that same year; and

WHEREAS, Robert McNeely is currently responsible for coordination of the bank's community development efforts and serves as the Community Reinvestment Act officer, in addition to his duties as the chairman and chief executive of the Union Bank of California Foundation; and

WHEREAS, Robert McNeely is vice chair of the Board of Directors for Centre City Development Corporation and past president of the Board of Trustees for the California Historical Society; and

WHEREAS, Robert McNeely's volunteer efforts are many and diverse, serving as chair of the Board of Directors of the New Covenant Trust Company, director of the San Diego County Dental Health Foundation, Advisory Board Member for the Neighborhood Bancorp, and committee member on the Small Business Fund Advisory Committee for the City of Los Angeles' Community Development Department; and

WHEREAS, Robert McNeely also serves as a director for Social Compact and is a member of the President's Diversity and Equity Community Advisory Council at San Diego State University and the President's Community Council at Point Loma Nazarene University; and




