A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE CITY OF SAN DIEGO'S 2010-2014 FIVE YEAR CONSOLIDATED PLAN AND FISCAL YEAR 2010 ANNUAL ACTION PLAN AND AUTHORIZING THE CHIEF EXECUTIVE OFFICER OF THE HOUSING COMMISSION TO SUBMIT THE PLAN TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT.

WHEREAS, the City's Fiscal Year 2010-2014 Consolidated Plan [Plan] continues a consolidated process for four U.S. Department of Housing and Urban Development [HUD] housing and community development formula-based programs: Community Development Block Grant [CDBG], HOME Investment Partnerships [HOME], Emergency Shelter Grants [ESG], and Housing Opportunities for Persons with Aids [HOPWA]; and

WHEREAS, this process replaces all current HUD planning and application requirements with a single submission and satisfies the regulatory requirements for the four HUD formula programs; and

WHEREAS, the Plan describes how the City is meeting statutory requirements of specified federal grant programs which set forth three basic goals, each of which must primarily benefit low-and very low-income persons: (1) to provide decent housing; (2) to provide a suitable living environment; and (3) to expand economic opportunities; and

WHEREAS, the Plan was developed by an interagency working committee composed of

the San Diego Housing Commission, as the lead, the City's Planning and Community Investment Department, and the San Diego County's Department of Housing and Community Development; and

WHEREAS, the San Diego Housing Commission will continue to plan, coordinate, operate, administer, implement and draw down funds for operation of the HOME program, as previously authorized by the City Council in prior resolutions, including but not limited to, Resolution Nos. R-284352 and R-286709 and the County of San Diego will continue to plan, coordinate, operate, administer, implement and draw down funds for operations of the HOPWA program; and the City's Planning and Community Investment Department will continue to administer, implement and draw down funds for operation of the CDBG and ESG programs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City's federally required Fiscal Year 2010-2014 Consolidated Plan, a copy of which is on file in the office of the City Clerk as Document No. 3048, is approved, and the Chief Executive Officer of the Housing Commission is authorized to submit the Plan, on behalf of the City, to the U.S. Department of Housing and Urban Development for its review and approval.
