A RESOLUTION APPROVING THE PLANS AND SPECIFICATIONS AND EXPENDITURE OF FUNDS REGARDING SEWER GROUP 715

WHEREAS, Sewer Group 715 [the Project] is part of the City of San Diego's Sewer Main Replacement Program as mandated by the Environmental Protection Agency; and

WHEREAS, this Project is located within the La Jolla Community Plan Area, and includes the construction and replacement of approximately 8,079 linear feet of existing 8-inch and 6-inch sewer mains, and rehabilitation of approximately 2,900 linear feet of existing 15-inch, 12-inch, 10-inch, 8-inch and 6-inch sewer mains and appurtenances; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego [Council] that the plans and specifications for the construction of the Project as advertised by the Purchasing and Contracting Department, filed in the office of the City Clerk as Document No. RR-304903, are approved.

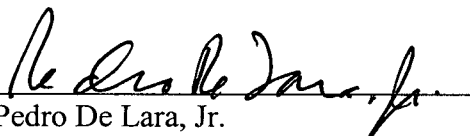
BE IT FURTHER RESOLVED, that after advertising for bids in accordance with law, the Mayor, or his designee is authorized to execute a construction contract with the lowest responsible and reliable bidder, provided that the City Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$4,486,447.15 from Sewer Fund 41506, CIP No. 44-001.0, Annual Allocation – Sewer Main

Replacements is authorized solely construction, contingency and Project related costs, contingent upon the City Council approval of the Fiscal Year 2010 Appropriation Ordinance, and the City Comptroller first furnishing one or more certificates certifying that the funds are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
