RESOLUTION ACCEPTING THE DEDICATION OF STREET
RIGHT-OF-WAY FOR A PORTION OF VALENCIA
PARKWAY AND AUTHORIZING THE NAMING OF THAT
PORTION OF VALENCIA PARKWAY.

WHEREAS, in 1989 the City of San Diego [City] acquired 14.23 acres of property for the Valencia Canyon Open Space Project; and

WHEREAS, as part of the Valencia Canyon Open Space Project: (1) a portion of Lot 14 and Lot 16 of the partition of a portion of Rancho Mission of San Diego, according to Map thereof No. 330, filed in the Office of the County Recorder of San Diego County on January 14, 1986, was used to construct a portion of Valencia Parkway which runs through Valencia Canyon [Right-of-Way]; (2) upon completion, the Right-of-Way was to be dedicated to the City for street right-of-way purposes; and (3) the Right-of-Way was to be named "Valencia Parkway" consistent with the remainder of that same City street; and

WHEREAS, it has been discovered that the Right-of-Way was never dedicated for right-of-way purposes and, as a result, the Right-of-Way area currently remains designated as "Open Space"; and

WHEREAS, in order to clearly define which City department (Public Works Department/ Streets Division or Park & Recreation Department) has maintenance responsibilities over the Right-of-Way, authorization is sought to dedicate the Right-of-Way for street purposes; and


WHEREAS, it has also been discovered that the Right-of-Way area was never properly named "Valencia Parkway", consistent with the remainder of that City street; NOW, THEREFORE,

BE IT RESOLVED, that the Mayor, or his designee, is authorized to take all actions necessary to facilitate the dedication, for street purposes, of that area described as a portion of Lot 14 and Lot 16 of the partition of a portion of Rancho Mission of San Diego, according to Map thereof No. 330, filed in the Office of the County Recorder of San Diego County on January 14, 1986, used to construct that portion of Valencia Parkway which runs through Valencia Canyon.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to take all actions necessary to facilitate the naming of that portion of Valencia Parkway which runs through Valencia Canyon, as "Valencia Parkway", consistent with the name of the remainder of that City Street.
