WHEREAS, on October 18, 2007, the City Council adopted an ordinance, which is on file with the Office of the City Clerk as Document No. O-19671, and codified at San Diego Municipal Code sections 26.2101 to 26.2103, creating the Past Grand Jurors Association Implementation Review Board [Board]; and

WHEREAS, the Board was established to provide the Mayor and City Council with a pool of experienced citizens who have served as members of the San Diego County Civil Grand Jury, who can assist and advise the Mayor and City Council in the process of reviewing the implementation of County Civil Grand Jury accepted recommendations; and

WHEREAS, the Board consists of seven members who are appointed by the Mayor and confirmed by the City Council; and

WHEREAS, all members of the Board shall be members of the Past Grand Jurors

Association of San Diego County, except that no more than two of the seven Board members

may be from the most recent County Civil Grand Jury; and

WHEREAS, all members of the Board shall be residents of the County of San Diego; and WHEREAS, the Mayor shall appoint members to the Board from a list of nominations submitted by the Executive Board of the Past Grand Jurors Association of San Diego County; and

WHEREAS, members shall serve two-year terms; and

WHEREAS, the two-year trial period of the Board is set to expire on December 1, 2009; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following reappointments by the Mayor of the City of San Diego to serve as members to the Past Grand Jurors Association Implementation Review Board, for terms ending as indicated, be and the same are hereby confirmed:
