A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE THE FISCAL YEAR 2010 OPERATING AGREEMENT FOR THE EAST VILLAGE BUSINESS IMPROVEMENT DISTRICT.

WHEREAS, on April 27, 2009 the Council of the City of San Diego [City Council] adopted Resolution No. R-304830, declaring its intention to form a parking and business improvement area to be known as the "East Village Business Improvement District" [District], providing for the levy of assessments, setting forth the specific improvements and activities to be funded by the assessments and the budget for each, and fixing the time and place for a public hearing regarding the formation of the District and giving notice thereof; and

WHEREAS, after the public hearing on June 23, 2009, the City Council introduced Ordinance No. O-2009 - [3], establishing the District; and

WHEREAS, the City of San Diego [City] is committed to supporting BIDs because they strengthen the small business community, create new jobs, attract new businesses, and revitalize older neighborhood commercial districts across the City; and

WHEREAS, the City's Office of Small Business assists the BIDs in a variety of ways, including providing loans to newly-established BIDs in order to help those newly-established BIDs promptly begin implementing the improvements and activities within their districts; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that contingent upon Ordinance No. O-209-131 becoming effective September 1, 2009, the Mayor (or his

designee) is authorized to execute the Fiscal Year 2010 operating agreement with East Village Association, Inc. for the East Village Business Improvement District, said agreement being on file with the Office of the City Clerk as Document No. RR-305027

BE IT FURTHER RESOLVED, that the City may advance an amount not to exceed twenty thousand dollars (\$20,000) from the City's Small Business Enhancement Program funds to East Village Association, Inc., which shall be reimbursed to the City by East Village Association, Inc. within twenty-four (24) months of the establishment of the District.
