A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING FISCAL YEAR 2009 MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF SAN DIEGO AND THE SAN DIEGO POLICE OFFICERS ASSOCIATION.

WHEREAS, from January 2008 through April 2008, pursuant to the Meyers-Milias-Brown Act, at California Government Code section 3500 *et seq.*, the Management Team of the City of San Diego [Management Team] met and conferred with the San Diego Police Officers Association [POA] regarding wages, hours, and other terms and conditions of employment for fiscal year 2009; and

WHEREAS, the Management Team reached a one-year tentative agreement with POA for fiscal year 2009 Memorandum of Understanding, effective July 1, 2008 through June 30, 2009; and

WHEREAS, pursuant to California Government Code section 3505.1 and San Diego City Charter section 11.2, it is necessary and appropriate for the tentative agreement reached between the Management Team and POA to be presented to the City Council for final determination; and

WHEREAS, on April 21, 2008, the City Council adopted Resolution Number R-303562, acknowledging the tentative agreement reached between the Management Team and POA regarding the provisions contained in the term sheet and resolving that the final Memorandum of Understanding was to be returned to the City Council for approval; and

WHEREAS, the Memorandum of Understanding between the City of San Diego and POA, for the period of July 1, 2008 through June 30, 2009, is now before the City Council for approval; and


WHEREAS, a copy of the Memorandum of Understanding shall be placed on file in the Office of the City Clerk; and

WHEREAS, nothing within the Memorandum of Understanding for fiscal year 2009 or this Council action is intended to supersede or otherwise modify the action the City Council took on April 14, 2009, by the adoption of Resolution Number R-304804, imposing terms and conditions of employment for members of POA, beginning July 1, 2009; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council of the City of San Diego hereby approves the Memorandum of Understanding between the City of San Diego and POA for fiscal year 2009, which was tentatively agreed to by the Management Team and POA, to be effective July 1, 2008 through June 30, 2009.
