RESOLUTION NUMBER R- 305030

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REGARDING THE FY 2010 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM.

WHEREAS, the Housing and Community Development Act of 1974 established the Community Development Block Grant [CDBG] Program, which is administered by the U.S. Department of Housing and Urban Development [HUD]; and

WHEREAS, the City of San Diego [City] has received CDBG Entitlement funds annually since its inception; and

WHEREAS, the overarching goal of the CDBG Program is to develop viable urban communities through the provision of decent housing, suitable living environments, and economic activities for persons of low and moderate income; and

WHEREAS, on March 3, 2009, the City Council approved a Fiscal Year 2010 CDBG allocation in the amount of \$13,366,448, a dollar amount that was based on an estimated 10% reduction in the City's CDBG award for FY 2009; and

WHEREAS, as part of the allocation process, the City Council allocated \$269,358 for the San Diego Housing Commission [SDHC] and earmarked future FY 2010 CDBG funds for SDHC in the amount of \$902,003 in order to match the amount awarded to SDHC in FY 2009, contingent upon the City's actual award of CDBG funds from HUD exceeding the estimated award; and

WHEREAS, the City has received official notification from HUD that the City's FY 2010 CDBG award totals \$15,027,728, which represents an increase of \$1,661,280 over the estimated award amount; and

WHEREAS, the Mayor has proposed that the entire balance of \$1,661,280 go to the City Council for allocation rather than applying the 60/40 Council-Mayor formula set forth in Council Policy 700-02; and

WHEREAS, on March 3, 2009, the City Council approved a Fiscal Year 2010 Emergency Shelter Grant [ESG] allocation in the amount of \$598,129, a dollar amount that was based on an estimated 10% reduction in the City's ESG award for FY 2009; and

WHEREAS, the City has received official notification from HUD that the City's FY 2010 ESG award totals \$664,558, which represents an increase of \$66,459 over the estimated award amount; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- That the City Comptroller is authorized to accept Community Development Block
 Grant [CDBG] funds from the U.S. Department of Housing and Urban Development for the
 City's FY 2010 CDBG Program.
- 2. That the City Comptroller is authorized to accept Emergency Shelter Grant [ESG] funds from the U.S. Department of Housing and Urban Development for the City's FY 2010 ESG Program.
- 3. That Paragraph No. 4 of Council Policy 700-02, the section dealing with the 60/40 formula for allocating CDBG funds, is hereby waived.

- 4. That the City Council's additional funding recommendations set forth in this second allocation hearing for the City's FY 2010 CDBG and ESG Programs, including the \$902,003 for SDHC, are approved and should be incorporated into an amendment to the City's FY 2010 Annual Action Plan.
- 6. That the Mayor or his designee is authorized to negotiate and execute agreements, with those agencies for which projects and programs have been approved for CDBG and ESG funding, contingent upon certification of funds availability by the City Comptroller.
- 7. That the Financial Management Department is authorized to appropriate and the City Comptroller is authorized to expend the CDBG and ESG funds for those projects and programs approved for CDBG and ESG funding, contingent upon certification of funds availability by the City Comptroller.


